On March 6, 2010, Jon Shannon, a 1987 graduate of Bellaire High School was diagnosed with double pneumonia. Jon, who is usually extremely healthy, was immediately admitted into the hospital. A day later, Jon was in the Intensive Care Unit, medically sedated and on a ventilator. He was diagnosed with Adult Respiratory Distress Syndrome, or ARDS. Finally, after two months in ICU, Jon is now on the path to recovery in a rehabilitation hospital where is working on regaining his strength before he can return home to his wife, Amelia, and their 17-month-old little boy, Judd.

Unfortunately, ARDS is not the only battle that Jon and Amelia are fighting. Jon, a self-employed contractor, continues to be unable to work and will not be able to resume working for an indefinite period of time. At this time, Amelia's salary does not cover their family's basic needs. They have received much-needed support from family and friends since the crisis began, and they will continue to need help until Jon is back on his feet.

As graduates of Bellaire High School, a group of us decided that we, Alumni of Bellaire High School, should support each other in times of need. With this in mind, we have organized the First Annual Charity Golf Tournament. This year we will be donating proceeds to Jon Shannon and his family. We hope to have a golf tournament each year that will benefit other Bellaire High School Alumni during their time of need.
